

The 1% annual flood (1,00-year flood), also incern as the base flood, is the flood that has a 1% chance of being equaled or exceeded in any given year. The Special Flood Heard Area is the area subject to flooding by the 1% annual chance flood. Areas of Special Flood Heard Include Zones A, AE, AH, AQ, AR, AP9, Y, and VE. The Base Flood Elevation is the water-surface elevation of the 3% annual chance flood.
